What is the Level 3 Certificate in Letting and Managing Residential Property?

The [Level 3 Certificate in Letting and Managing Residential Property](#) is a 24 week online vocationally related qualification for the property sector in England and Wales, which provides individuals with the knowledge required to work in a frontline role in letting and managing residential property, provides individuals with the knowledge required to work in a frontline role in letting and managing residential property, in England and Wales.

You will study four units:

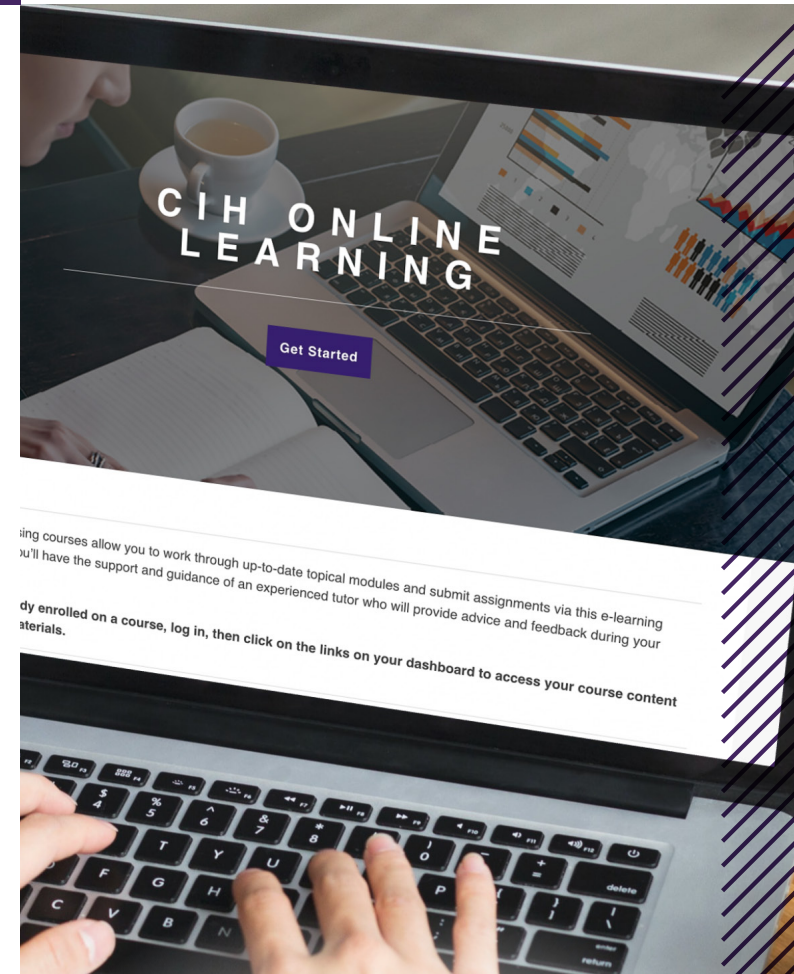
- ❑ Letting residential properties
- ❑ Property standards for residential properties
- ❑ Tenancy management for residential property
- ❑ Ending tenancies of residential property

In addition to the mandatory units above we also offer an additional, optional, unit specifically aimed at letting agents; **'Professional practice for letting agents'**.

This unit aims to provide an understanding of the relationship between the agent and landlords and tenants. It also looks at business development and learning through experience.

To complete this qualification, you are required to study for approximately six-eight hours a week, this can include investigation undertaken at work and independent study time working through the online materials, completing additional reading and research, and writing up your submissions.

If you wish to complete the optional unit in Professional Practice for Letting Agents, this will take an additional six weeks to complete this unit.

Why study this qualification?

Gaining a qualification at this level is a great way to develop your career prospects. Qualifications at this level enable you to perform your role to a high standard, provide an excellent service to your tenants, and develop your knowledge of housing legislation and best practice.

Who should apply for this qualification?

This qualification focuses on the housing industry in England and Wales, and is suitable for:

- ❑ Individual landlords, letting one or a small portfolio of residential properties
- ❑ Letting and managing agents
- ❑ Housing association staff letting and/or managing market-rented properties
- ❑ Housing advice workers
- ❑ People in, or aspiring to, a front-line role in letting and managing residential property

Applicants must be aged 18 or over, be confident using IT and have access to a computer.

To register on this qualification you should have a level 2 qualification and/or experience of working in letting and managing residential property, preferably in a frontline role. (CIH also offers the [Level 2 Award in Letting and Managing Residential Property](#) as an online qualification).



What will I learn?

Property standards for residential properties (mandatory)

- ❑ Understand the legislation relating to property maintenance and repair
- ❑ Understand procedures for property maintenance
- ❑ Understand the definition of a house in multiple occupation and the extra responsibilities this places on landlords
- ❑ Understand licensing schemes and the extra responsibilities they place on landlords.

Tenancy management for residential property (mandatory)

- ❑ Understand the financial aspect of letting a property
- ❑ Understand how agreements can change during the tenancy
- ❑ Understand how tenancy issues are prevented and resolved.

Letting residential properties (mandatory)

- ❑ Understand different types of tenancies
- ❑ Understand how to prepare a property to let
- ❑ Know how to market properties to let
- ❑ Understand the requirements for selecting a tenant and setting up a tenancy.

Ending tenancies of residential property (mandatory)

- ❑ Understand how a tenant can end the tenancy
- ❑ Understand how a landlord can end the tenancy
- ❑ Understand the legal process for a landlord to obtain possession.

Professional practice for letting agents (optional)

- ❑ Understand the terms of business with landlords, tenants and agents
- ❑ Understand the business development opportunities
- ❑ Understand how to assess own performance.



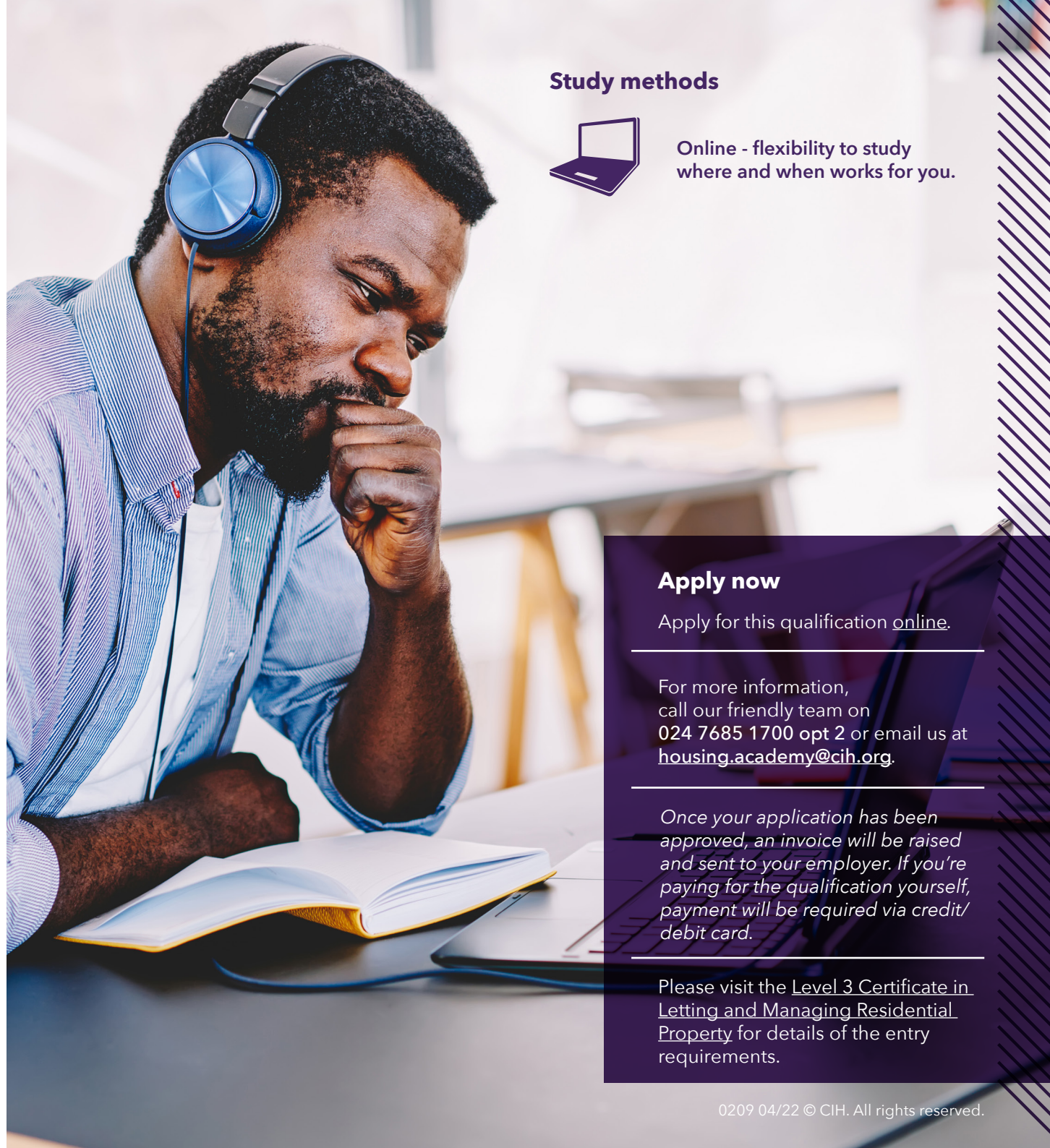
What can I expect as a CIH online learner?
