What housing qualification should I study? A guide



Housing and property management qualifications help housing practitioners develop their knowledge and advance their career. The below graphic can you identify the different types of housing qualification you may wish to study at different stages of their career. This table at the supporting profiles are illustrative of the types of qualification you may wish to study. Learner Profiles

These profiles are a guide to the type of qualification learners may choose to study. They are not exhaustive or exclusionary and as with the above table learners should speak to your employer or contact one of the Scottish housing <u>learning centres</u> in the first instance. **Greig** has recently graduated from University and has secured a role with a housing association as part of their new graduate programme. This is a 2-year programme that seeks to give graduates an experience of front line housing and develop them into leaders of the future. Greig see's himself as a future leader in the sector. Grieg may consider studying a CIH level 4 in the first instance or even post graduate qualifications- given his ambition and academic background. **Susie** has worked for NHS for 25 years, most recently in a senior post but has been recently appointed as head of housing for a leading housing association. She is a member of the housing association's SMT and is keen to enhance her understanding of strategic housing matters to support her team. As a leader in the organisation Susie should consider studying for her CIH level 5 qualification so she can better understand the strategic decision made for landlords. Susie may also wish to consider a post graduate qualification.

Svetlana works for a homelessness charity as its communication and public affairs director. She has worked in the housing charity sector for 10 years but never for a landlord has never considered herself a housing professional before but has started to think about her own career and professional development. As a senior manager in the organisation and she should consider studying a CIH level 4 qualification to give her a more reflective understanding of housing law, policy and practice. Alan has just joined the council's housing department as a housing officer. He previously worked for an NGO in an administrative role but has no direct experience in housing management before this role. Alan is keen to better understand what the housing sector involves so he can do his job to the best of his ability. Alan should consider studying for a CIH level 2 qualification in the first instance but then in 12 months' time consider studying for his level 3 to improve his housing knowledge.

Clive is a PRS landlord who owns x2 flats in Edinburgh city centre. He manages the lets himself. He wants to improve his professional standing among his peers and customers. Clive should study for his CIH level 3 Certificate in Letting and Managing Residential Property. This will give him a grounding in relevant PRS legislation in Scotland. However once completed he should consider more senior qualifications reflecting his role as a landlord.

Chloe is a new housing officer with a local housing association, having previously had the same role with a local authority. She has worked in the sector for one year. The housing association has offered her training and support as she has no existing housing qualifications. Chloe is excited to take up the opportunity to enhance her own professional development. Chloe should consider studying for a CIH level 3 qualification in the first instance and then consider more senior qualifications in the future depending on her career ambitions

Imran has been working at his local authority as housing officer for 3 years. He has achieved his level 3 qualification but is ambitious and one day wants to become the head of housing at the local authority. Imran is experienced writing essays and should consider studying for a level 5 or post graduate qualification. This will help highlight his commitment to ongoing professional development and help give him the skills and knowledge to secure a more senior post. **Dave** has managed a letting agency for 15 years and has hundreds of PRS properties to look after. Dave already has a CIH level 3 Certificate in Letting and Managing Residential Property as it is a legal requirement and he is a graduate. Dave is a leader in Letting sector and keen to demonstrate the sector's commitment to customer service and professionalism. Dave should study for a PG housing qualification to demonstrate his commitment to professional standards and better understand the strategic place of his business in the housing market

Fatima has worked for a housing association for 15 years in the finance team. She started her career as an officer but now leads the team and is a member of the SMT. She is a member of the Chartered Institute of Public Finance and Accountancy Fatima see herself as a leader in the organisation and increasingly as housing professional too. Fatima should study for her CIH level 5 or post graduate qualification to complement her other professional qualifications.
