CIH news

CIH and NHF have announced the establishment of an independent panel to look into the reports of poor housing conditions and quality that have emerged recently. The panel will talk to social housing residents and a broad range of people to understand how these issues have arisen and what the sector needs to do to improve housing conditions and the experience for people living in social housing. It will be led by Helen Baker, whose career has spanned housing, health, social care and education. More about the panel can be found here.

CIH influencing



The policy team submitted evidence to All Party Parliamentary Groups: on Ending Homelessness - on progress on the government's target on rough sleeping - and on Housing and care for older people - on making retirement housing affordable and the role of shared ownership.

We also submitted responses to government consultations around domestic abuse, specifically on local connection requirements for social housing for victims of domestic abuse and the impact of joint tenancies, and on homelessness regarding proposed replacement legislation for the Vagrancy Act.

Our consultation responses and evidence submissions are shaped by input from you, our members, so many thanks to all who gave comments and case studies. There are also more opportunities to comment on forthcoming consultations as below.

Other news from the sector

Crisis has published a report looking at the experiences of people over three years since the Homelessness Reduction Act. <u>A Foot in</u> the Door: experiences of the Homelessness Reduction Act 2018-2021 explores some positive changes that it has brought in but also the limitations and negative experiences.

Leading sector bodies gave their responses to the government's proposals to extend the right to buy to housing associations, in which all expressed concerns about the likely loss of affordable homes at a time of housing and other costs of living crisis. CIH's response is here, including links to our analysis on the impact of Right to Buy to date. See comments from LGA, NHF, National Federation of ALMOs and Association of retained council housing (ARCH).

The Housing Ombudsman has published a <u>podcast</u> that looks in detail at a recent repairs case concerning damp and mould to provide some learning and improvement tips for social landlords. It has also <u>called</u> for

housing providers to resource and respect their complaints teams after issuing more complaints handling failure orders in January to March 2022 than any previous quarter.

Statistics and data

Homes England has published its <u>statistics</u> on housing starts and completions for 2021-2022. Whilst overall activity was up from 2020-2021, when housebuilding was impacted by measures to manage the pandemic, the number

of affordable housing starts overall was 2 per cent lower, with social rent starts down 23 per cent down on the previous year. However, completions of affordable homes was up by 11 per cent, with social rent completions up by 62 per cent, delivering 3,077 homes compared to 1,896 completions the previous year.

The GLA have <u>recorded</u> 18,722 affordable home starts and 10,252 completions for the year, with 9,698 social rent starts and 3,291 completions.
