Focus on Influencing Scotland APRIL 2022

The Scottish Government's commitment to end homelessness in Scotland is laudable and the recent proposals to introduce a prevention duty will help to change the culture around homelessness and challenge the perception that homelessness is just a housing issue. If we are to truly end homelessness in Scotland, we need everyone to be working together from housing providers to health care providers, prisons and children's services. Every contact with a person who is at risk of homelessness is an opportunity to prevent homelessness.

However, while we welcome the principles of the proposed prevention duty, our response to the Scottish Government consultation raised some concerns. For the duty to be effective, staff across different public bodies will need training to ask the right questions and take appropriate actions and this has not been addressed in the proposals. We also have concerns with the suggestion that some people may be offered 12 month tenancies. This represents an erosion of the rights of homeless households who currently have the right to permanent accommodation.

We look forward to working with the Scottish Government and COSLA as the proposals are further developed to make sure that CIH member views are reflected in the legislation.

Housing First Scotland

CIH Scotland director, Callum Chomczuk, chaired a keynote session at Homelessness Network Scotland's Housing First conference in Edinburgh on 31 March. The discussion focussed on the need to ensure everyone has a genuine choice of social housing and what can be done to give better support, renumeration and regard to those working in the housing sector.

Shared Understanding of Affordability

CIH Scotland has joined a Scottish Government short-life working group to reach a consensus on a shared understanding of housing affordability as set out in Housing to 2040. The group will be chaired by Professor Ken Gibb, Director and Principal Investigator of the UK Collaborative Centre for Housing Evidence and Professor of Housing Economics at the University of Glasgow and will include landlord and tenant representation. The group should report within one year.

Letting agent CPD review

As part of its review into the impact of letting agent CPD on professional practice, CIH has appointed a research consultant to take on the role and now established a sounding board to provide oversight on the project. This includes representatives from Scottish Association of Landlords, Council of Letting Agents, Landlord Accreditation Scotland, ARLA, one commercial letting agent (Homes for Good), and one RSL subsidiary letting agent (Link Group). Work is ongoing looking at existing data sets ahead of tenant and stakeholder surveys and we expect to report in the autumn.

Rent Better - improving performance in the private rented sector

The Rent Better project was commissioned by the Nationwide Foundation with the aim of assessing the impact of recent changes to private sector regulation in Scotland, particularly the introduction of the Private Residential Tenancy. The Rent Better Advisory Group, of which CIH Scotland is a member, met to consider findings of the second wave of research and consider conclusions from phase two of the project.
