Focus on Influencing Scotland July 2023



Ahead of Scottish Government legislation expected later in this parliamentary term, we have published a new discussion paper setting out considerations as to the scope and feasibility of a regulator for the private rented sector (PRS).

In the paper, we note that the Scottish Government has committed to establishing a regulator for the PRS and suggest it may have similar scope to the existing social housing regulator and may also include a charter to empower tenants who will need to understand those standards.

However, while recognising the potential benefit of such an initiative, the paper also draws caution on the scope of any new regulator, recommending that any changes have to be informed by evidence, that they are proportionate so that any reforms so not undermine the supply of PRS properties across Scotland, and it sets out the need for any regulatory changes to be matched with appropriate investment in the private housing sector from the government.

We believe the introduction of a PRS regulator could be an opportunity to improve standards and tenant experiences across the sector. Our feedback shows that tenants are mostly concerned that standards of their home and property management are of a sufficiently high level, while landlords are concerned about having access to up-to-date information and advice.

Any reform mustn't be about simply adding regulation to the PRS but instead recognising the need to create a greater understanding about rights, responsibilities and accountability among tenants and landlords. And crucially, realising that regulation by itself cannot drive improvements in housing outcomes but must be matched by investment from the government.

Meeting the Housing Minister

National director, Callum Chomczuk, and policy and practice manager, Ashley Campbell, met with Paul McLennan MSP Minister for Housing on 20 June. We discussed a range of member priorities including the future of rapid rehousing transition plan funding, the upcoming Housing Bill, professionalisation of the housing sector and domestic abuse.

Housing and independent living

Ashley Campbell, policy and practice manager, gave a presentation on housing and dementia at the Scottish Government's Accessible Housing and Independent Living stakeholder group in June. The recent publication of a new National Dementia Strategy, which addresses the role of housing much more clearly than previous versions, creates an opportunity to build on relationships between housing, health and social care and ensure better housing outcomes for people living with dementia. Sharing practice

We recently hosted a delegation of Dutch practitioners at a special session on housing and health in Glasgow. Policy and practice manger Ashley Campbell was joined by CIH board member and professor of urban studies at the University of Glasgow Craig Gurney, and chief executive of Hanover Scotland Angela Currie to share learning on housing and homelessness, social harm and independent living. Housing to 2040

CIH Scotland is a member of the Housing to 2040 Strategic Board, tasked with delivering an action plan for the Scottish Government's long term housing strategy. The group, co-chaired by Paul McLennan MSP and Councillor Maureen Chalmers, met for the second time in June to discuss a new workplan and priorities for the sector.

Domestic Abuse

Following the publication of CIH Scotland and Scottish Women's Aid report on social landlord domestic abuse policies, national director Callum Chomczuk presented the findings to the Scottish Government's Homelessness team, making clear the report's recommendation that mandatory policies are required for social landlords and that they must be based on the CIH/SWA good practice guidance from 2019.

Damp and Mould

National director Callum Chomczuk gave evidence to the Scottish Parliament's Local Government, Housing and Planning Committee on the prevalence of damp and mould in the sector. In his evidence, he set out the steps the social sector was taking to address the issue and the development of proactive data sets allowing landlords to be more systematic in their approach to eradication.

Homelessness

CIH national director Callum Chomczuk spoke at Housing 2023 in Manchester about the drivers behind the higher level of lets to homeless households by RSLs in Scotland compared with the rest of the UK, and set out lessons for other jurisdictions about how this outcome can be replicated.


