

# Fees Valid from 1 April 2022 to 31 March 2023 CIH Awarding Organisation

#### New centre approval

£740

On receipt of a centre approval application form, centres will be charged a non-refundable fee of £740 to cover the process for centre approval.

#### **Annual centre registration**

£590

An annual fee of £590 is chargeable to all approved centres. It covers the 12 month period from the date of initial approval for the following services:

- Annual external quality assurer visit
- Annual centre forum
- Administration and other support
- Moodle access

# Supplementary fees for services available to centres

### Approval to deliver an additional qualification

£360

On receipt of an application to deliver a new qualification/additional unit/s form, where a centre has applied to deliver an entirely new qualification, centres will be charged a non-refundable fee of £360 to cover the approval process including the approval of associated assessment tasks.

#### Approval to deliver additional unit/s

£52

On receipt of an application to deliver a new qualification/additional unit/s form, where a centre has applied to deliver additional units for a qualification that it already has approval for, centres will be charged a non-refundable fee of £52 per unit to cover the approval process including the approval of associated assessment tasks.

# Additional external quality assurance visit

£600

If centres require additional support visits, these are chargeable at £600 per day (inclusive of expenses).

# Additional external quality assurance/moderation support

£182

If centres require additional quality assurance or moderation support this is chargeable at £182 per day.

# Assignment approval (third submission) per assignment

£38 +VAT

Centres are required to have assignments approved for units of qualifications. This service is not charged for on the first and second attempt. However, if the assignment must be reviewed a third time a charge to contribute to this cost will be made.

# Standard qualification fee per learner

Centres will be charged a non-refundable fee for each learner that they register with CIH for a qualification or unit/s. An e-certificate is provided for every learner achieving a qualification as part of the standard qualification fee. If the learner requires a printed certificate an additional fee is chargeable.

Centres must register learners on the most appropriate qualification or combination of units. If a learner defers and returns to learning within a year, the centre will not be invoiced again provided the learner is still aiming to complete the original qualification or combination of units that they are registered against.

The standard qualification fee reflects the most likely combination of units learners will be undertaking to achieve the qualification. If the learner takes more than the minimum number of units these will be charged at the per unit rate.

The standard qualification fee per learner is calculated on the basis of registration fee plus, number of units taken based on level.

Registration fee£46Learner level 2/3 unit fee£19.00Learner level 4/5 unit fee£26.50

Learners are able to undertake single units of the qualifications, based on the fees above (for example a learner undertaking a level 2 unit would be chargeable at £65.00 and then subsequent units at £19.00). If the learner goes on to achieve all of the units required for the qualification, a second £46 charge will be made at the point they upgrade their unit achievement to a full qualification achievement.

# **Associated learner fees**

#### Printed certificate charge

£38 +VAT

Centres must check all learner details are correct at the point of claiming a e-certificate. Should a learner require a printed certificate these are chargeable at £38 +VAT and be claimed through the e-certificate portal.

#### Learner transfer fee

£38 +VAT

If a learner starts a qualification but then transfers their registration to and completes a different qualification a transfer fee is chargeable along with a fee for any additional units as appropriate.
